## L&G Multi-Index V Series 1 - Investment Bond Option A



### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

### Product

The Investment Bond, is issued by Aviva Life & Pensions Ireland dac, registered in Ireland No. 165970. The website is aviva.ie and the phone number is (01)8987950. ### What is this product?

#### Type

The Investment Bond is a unit-linked investment product offering access to a range of investment funds. The investor may choose the investment fund or investment funds in which he/she wishes to invest. You have chosen the L&G Multi-Index V Series 1 Fund.

#### Objectives

Our L&G Multi-Index V Fund invests in the L&G Multi-Index EUR V Fund (the "underlying fund"), a sub fund of the L&G ICAV. Unless otherwise stated when we refer to the fund we are referring to the underlying fund. The investment objective of the fund is to generate capital growth through exposure to a diversified range of asset classes, predominantly in other collective investment schemes. The fund is expected to have a level of risk which broadly corresponds with the level 5 UCITS synthetic SRRI. This may not be achieved

#### Intended retail investor

This fund is designed for customers who are seeking an investment consistent with the fund objectives as outlined above and are comfortable with the possible performance scenarios outlined below.

#### Insurance benefits and costs

The death benefit under the product is 100.1% of the value of the policy on the date immediately following the date we are informed of the death (less any exit tax due).

### What are the risks and what could I get in return?

#### Summary Risk Indicator (SRI)

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you. You are not entitled to receive back a minimum percentage of your capital. The amount you will receive will be related to the value of the funds at the time of death or surrender which depends on future market performance and is uncertain. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.



The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

## How long should I hold it and can I take my money out early?

Recommended holding period in years: 7

The Recommended Holding Period has been selected to be long enough to smooth out the variation in returns over time. This product is intended as an open-ended investment. You may access the fund value at any time but may be charged a percentage fee for doing so. The exit fee applicable in Year 1 is 5%, in Year 2 is 4%, in Year 3 is 3%, in Year 4 is 2% and in Year 5 is 1%. Please refer to the table in the Costs over Time section of this Key Information Document for clarification of the impact of such fees and penalties for different holding periods.
